PUBLIC HEALTH HOTEL GUEST INFORMATION – PLEASE READ CAREFULLY

Coronavirus

Guests and staff health and safety is always Louis Hotels number one priority. The hotel has implemented in accordance with EU and local government guidelines on the management of Coronavirus appropriate procedures to safeguard its guests and staff health and safety whilst **guests are staying in the hotel**. It is, therefore, essential that all guests using the hotel facilities **strictly** follow measures and guidance given by the hotel to prevent infection and virus transmission to a maximum.

By continuing with your stay you and every person in your booking acknowledges that you have made the informed decision to travel freely knowing full well the method of transmission of the virus and its possible consequences, and do not hold Louis Hotels, its directors, employees or agents operating within the hotel liable, should you contract the infection at any point during your holiday.

When you are at the hotel you must: -

- respect physical distancing: a distance of 1.5 to 2 meters should be applied in the communal areas of the whole hotel, (except for persons travelling together and sharing rooms.
- wash your hands with soap, dry them with single-use paper towels or automatic dryers, and use also alcohol-based hand rub solutions provided at various points in the hotel.
- cough or sneeze into a paper tissue. Paper tissues should be disposed of immediately after use, and hands should be washed/cleaned right away using the correct procedure. If paper tissues are not available, coughing or sneezing into the elbow bend is recommended.

Use of face masks: this can be considered as a means of source control (i.e. to prevent the spreading of droplets from infected people with or without symptoms). Appropriate use of face masks is important. The face mask should completely cover the face from the bridge of the nose down to the chin. The use of face masks can only be considered as a complementary measure, not replacing core preventive measures, which is to keep to the required social distance and following good hygiene standards including the regular washing of hands with soap and water and using alcohol-based hand rub solutions.

You must stay in your room if you experience at any time during your stay at the hotel minor symptoms such as cough, headache, mild fever, and get in touch with the hotel reception immediately. Avoiding contact with others will protect them from possible COVID-19 and other viruses. If you have a fever, cough and difficulty breathing, loss of taste and or smell. you must seek immediate medical attention, again get in touch with the hotel reception.

Upon departure, you are explicitly requested to immediately notify the hotel if you develop symptoms associated with COVID-19, or obtain a positive test result for COVID-19, within 14 days following departure.

Norovirus

If you have a sudden onset of severe vomiting and diarrhoea or you experience feeling sick, you may have the Norovirus infection. The Norovirus infection is highly contagious. Symptoms are diarrhoea, stomach pain and vomiting which typically begin 12 to 48 hours after exposure. Norovirus symptoms usually last one to three days, and most people recover completely without treatment. However, for some people — especially infants, older adults and people with underlying disease — vomiting and diarrhoea can be severely dehydrating and require medical attention. Therefore, you must stay in your room and get in touch with the hotel reception.

Louis Hotels Group reserves the right to ask the guest to fill in a Guest Gastric Illness Questionnaire and undergo a medical examination by a doctor. Also, Louis Hotels Group may ask the guest to undergo any test, including providing faecal samples, to verify the illness and identify the pathogen which has caused illness.
